3. Old Business

a. Dan Bartle and Ashley Shive provided a recap of the 2025 Florida Hazardous Materials Symposium. Dan saw a focus on lithium ion-batteries and remarked on the excellent presenters and information shared at the symposium. Ashley was able to see the amount of work that it takes to make sure there are good instructors and what it takes to have a successful symposium.

4. New Business

i. Curtis briefed the attendees on the recent Lakeland Linder International Airport's Full-Scale Exercise and Avello's Tabletop Exercise on February 11, 2025. This was a full-scale exercise using HMEP funds because of its hazardous component. Avelo was a participant in the exercise this year because they provide passenger services at the Airport. Several local, state and federal partners attended this year's exercise. CFRPC was able to hire a planning consultant, Advanced Planning Consultants, LLC to put on one of the smoothest exercises they have been a part of. During the reunification exercise several components were discussed

regarding the operations of the airlines, airport, and other partners, allowing Avello the opportunity to receive data that is critical to their operations at the airport.
