2. Old Business

Discussion on the possibility of changing the 2nd Quarter meeting to May 3, 2023 at 9:30am. Everyone in attendance was good with the change. Rick Christoff offered to host the May meeting in DeSoto County. Curtis clarified that we would continue to offer virtual attendance as an option for members who are not able to attend in-person meetings. Third quarter and fourth quarter meeting dates will not change; they are August 3, 2023 at 9:30am and November 16, 2023 at 9:30am respectively. Curtis reminded attendees that we do not have locations for these two meetings set.

Curtis offered a recap of the Central Florida LEPC Virtual EPCRA, E-Plan Tier 2 Workshop. Registrants leading up to the workshop estimated approximately 95 attendees while 51 attended.

Also reviewed was the recent 2022 Florida Hazardous Materials Symposium which hosted over 600 attendees. The LEPC sent 23 individuals to the symposium to attend and receive training. Going forward it seems that a location change will take effect for the Fire Rescue symposium in Orlando the week prior to the 2024 Florida Hazardous Materials Symposium event in Daytona Beach.

Daniel Bartle shared information on the [Chemical Companion](#) app. This is available for approved users with government/military email addresses required to register on the app.

3. New Business

Ashley Shive is working to put together a class during quarter two for cold tankers. Ashley will send information to Curtis to distribute.

Incident Report(s)/Discussion for the Region included some discussion on the investigation into the Carpenter Site fire. Carpenter site information was shared by Curtis who encouraged attendees to make sure their contact information is always updated.

Ashely reported that throughout the state some active investigations into illegal dumping are also ongoing. One example included 15 drums of purposely spilled hazardous waste; ACT is involved in assisting with the cleanup.

National incidents regarding recent train derailments with hazardous materials led the discussion into the recent spill in East Palestine Ohio. Vinyl Chloride was spilled, and the cleanup included burning the chemical which resulted in various local and national impacts. Cleanup has been extensive including waste leaking into the waterways.

4. Subcommittee Reports

- The membership report included information on the one membership application received. The application will be processed by the next SERC meetings. Curtis reminded attendees that applications were available if there were any non-members present or if they would like to forward that resource. Curtis received applications for Danielle DeLeon with Hardee County, Codi Donahoe with Polk County Fire, and a change in category for Todd Tanner.
- State Emergency Response Commission (SERC) for Hazardous Materials continues to have staff turnover at a high rate and currently has vacant positions. Staffing started with 11 but is now down to five. At the Jan 2023 SERC, TTF, and LEPC Chairs and Coordinators Meetings were provided newly appointed primary members: Jon Belcher and Heidi Hoffman and appointed new alternate members: Stacy Smith, Sean Lynch, and Alex Munoz. Awards were also distributed throughout the regions at the SERC meeting.

Next SERC, TTF, and LEPC Chairs and Coordinators Meetings

- The training report included items from the SERC Training Task Force and items occurring in the region:
 - A trial class for fentanyl training specifically geared for first responders was very well received. The class offered two options in AM and PM. Once the class is finalized and endorsed it is possible it will move out to LEPC. The rough estimate to distribute class around is \$100,000.
 - Open water class/training in conjunction with US Coast Guard was also received well. Another class will likely be conducted with a Miami team but is looking at completing training indoors if possible.
 - A report on the Orange County fireworks building in Orlando led to an investigation that could not determine how it started. The incident resulted in four deaths. According to building codes housing fireworks in the building was not approved. Questions about whether OSHA went in to investigate were raised.
 - Discussion on post-hurricane lan car fires prompted a project box with the SERC to look at electrical vehicles and training on how to deal with these fires. Included in the discussion were incidents of golf carts and e-bikes that are catching fire as well.
 - Training discussions addressed how things are moving in each region. Lengthy discussions on Hurricane Ian's search and rescue crews included

information on the 17 Teams that responded. Information was shared on the timely project for the bridge to Sanibel Island which took 17 days to construct.

- Curtis reported that an upcoming in-person Ammonia emergency response training would be available. Information on the CAMEO program class was sent out to LEPC members.
- Publix training recently completed a response to a potential ammonia spill scenario. Greg provided details of the scenario and how the training would resolve the issue. This was the first hands-on training since COVID, so it was a learning experience for hosts as well as attendees. The training offered a positive experience and an opportunity to review existing plans. The consensus on the best decontamination method for ammonia seemed to be to use fans.
- The Florida Division of Emergency Management sent an email regarding additional upcoming funding. Curtis reviewed the breakdown of funds.
- Florida Division of Emergency Management Training Calendar
Once registered the program will check to see if you have completed the pre-requisite for the currently registered class. Discussion on how the system is flawed because class titles change, often resulting in requiring attendance to previously completed classes.

SUBJECT: Hazardous Materials Incidents Report

SUMMARY: The attached tables and graphs provide information on all hazardous materials incident reports received by the State Watch Office for the period of up to December 1, 2022 through February 28, 2023. Incident reports are reviewed by staff on a daily basis for compliance with Section 304 and other provisions of the Emergency Planning and Community Right-to-Know Act (EPCRA) program. They can also be used to identify facilities that may have an obligation to report under the Risk Management Planning (RMP) program.

The "Potential Section 304 Investigations" information in Table 1 is listed by Local Emergency Planning Committee (LEPC) District. These are incidents involving the release of an Extremely Hazardous Substance (EHS) or a Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) chemical at a fixed facility. In order for an incident to be covered under Section 304, the EHS or CERCLA chemical must meet or exceed its designated Reportable Quantity (RQ) and have potential for offsite exposure. Those facilities found not to be in compliance with all Section 304 reporting requirements are referred to the Division of Emergency Management's General Counsel for possible enforcement action. The incidents listed in Table 2 cover hazardous materials incidents for which evacuations, injuries and/or deaths were reported. Also note that the official cause of death is determined by the medical examiner's office. This process may take up to 90 days. The numbers for these tables were obtained from the State Watch Office incident reports, as well as other sources. This information is still being recorded and is available upon request.

The figures in Graph I show the total number of hazardous materials incidents per year (including Section 304) reported to the State Watch Office for the period of December 1, 2022 through February 28, 2023. The figures in Graph II compare incidents that occurred at fixed facilities to those involving transportation-related incidents during the past 12 months. Note that the incidents in Graph II have been further refined to list petroleum, LNG and propane incidents.





SUBJECT: Update of Staff Activities and Reports by Section

SUMMARY: This is to provide the SERC with a status report on the number of reports filed under the Emergency Planning and Community Right-To-Know Act (EPCRA) and the Florida Accidental Release Prevention and Risk Management Planning (ARP / RMP) Act. It also provides an update on staff activities. The following is a breakdown of the number of notifications or reports that have been filed under EPCRA, by section, and the number of hazardous materials incidents reported to the State Watch Office.

A. Meetings/Exercises/Activations

Tier 2 staff delivered E-Plan filer training in eleven (11) virtual How to Comply Workshops hosted by nine (9) LEPCs to 344 workshop attendees. Workshop attendance increased by 34% over the previous year.

B. Verification/Tier II program

The total number of year 2022 Tier II reports in E-Plan is 11,394 (as of February 28, 2023). The total number of Tier II reports for year 2021 is currently listed as 12,973. The E-Plan Staff Tool “Not Filed Facilities” lists 1,391 sites that have a 2021 Tier II report with no corresponding year 2022 Tier II report filed in E-Plan. Staff will contact all facilities that have not filed for the current year.

The attached graphs provide information on Tier II and various activities conducted by the verification staff. The “E-Plan Filing - Total Facility Count” by LEPC graph (see Graph I) displays the total number of Tier II reports by LEPC for the reporting year 2022 (as of February 28, 2023). Graph II depicts the number of technical calls (per month) received by staff. Graph III depicts the total numbers of facilities & chemicals in E-Plan by year for the last seven reporting years (2017 through 2022). Graph IV shows the number of online payments for the last ten reporting years (2013 through 2023).

C. Risk Management Planning Program Planning

Staff provided outreach and technical assistance to 116 facilities and their staff. This was conducted by means of resubmissions, payment / fee information, RMP E*Submit user information, TRI outreach and fee monitoring, overdue and compliance verification, reconciliation of audit and inspection findings. 9 Risk Management Plan On-Site Inspections were conducted. Staff completed 7 final determination reports, and 2 document/ 10 Desk audits.

D. Radiological Emergency Preparedness (REP)

participated in FEMA Ingestion Pathway drill for counties at the St. Lucie NPP. Staff toured new Turkey Point EOF facility in September. Staff currently updating Radiological Emergency Management Plan for the State to bring it up to the 2019 FEMA REP Program Standards.


E. Public Information/Technical Assistance

Staff handled technical assistance calls and/or provided outreach assistance calls totaling 865 for the period of December 1, 2022, through February 28, 2023.




GRAPH I

BY LOCAL EMERGENCY PLANNING COMMITTEE DISTRICT




GRAPH II EPCRA FILING – TECHNICAL ASSISTANCE CALLS BY MONTH
