






#### Florida Wildlife Corridor

- Florida Wildlife Corridor Act became effective on July 1, 2021.
- Extends from the Everglades to Georgia and west to Alabama.
- Helps ensure Florida's wildlife populations are connected and protected.
- Developed to create incentives for sustaining and conserving the green infrastructure.
- Nearly 18 million acres in Florida, with 46% identified as Opportunity Areas, or areas of the Corridor not yet conserved.

#### Florida Wildlife Corridor

CFRPC, in partnership with Archbold Biological Station, identified areas where potential development may occur within the Florida Wildlife Corridor Opportunity Areas within the Heartland counties of DeSoto, Glades, Hardee, Hendry, Highlands, Okeechobee, and Polk.



#### Florida Wildlife Corridor

#### Data collected and analyzed included:

- Building permits
- Zoning changes
- Land suitability
- Generalized future land use
- Existing infrastructure relevant to future development

**Coordination with** State agencies, non-profit organizations, and landowners to identify Opportunity Areas potentially available for acquisition, voluntary conservation easements, or those requiring coordination to support new development or redevelopment projects.







## America the Beautiful Challenge (ATBC)

The National Fish and Wildlife Foundation (NFWF), through anticipated cooperative agreements from the Department of the Interior (DOI), Department of Defense (DoD), and the Department of Agriculture's U.S. Forest Service (USFS) and Natural Resources Conservation Service (NRCS), has announced the America the Beautiful Challenge (ATBC) 2022 Request for Proposals (RFP).



#### America the Beautiful: 8 Core Principles

- Collaborative and inclusive
- Conserve for the benefit of all people
- Support locally led efforts
- Honor private property rights and voluntary stewardship efforts
- · Honor tribal sovereignty
- Pursue approaches that create jobs
- · Use science as a guide
- Build on existing tools and strategies



#### America the Beautiful: 6 Areas of Focus

- Create more parks and safe outdoor opportunities in nature-deprived communities
- Support tribally led conservation and restoration priorities
- Expand collaborative conservation of fish and wildlife habitat and corridors
- Increase access for outdoor recreation
- Incentivize and reward the voluntary conservation efforts of fishermen, ranchers, farmers, and forest owners
- Create jobs by investing in restoration and resilience



#### **America the Beautiful Themes**

- Conserving and restoring rivers, coasts, wetlands and watersheds
- Conserving and restoring forests, grasslands and other important ecosystems that serve as carbon sinks
- 3. Connecting and reconnecting wildlife corridors, large landscapes, watersheds and seascapes
- Improving ecosystem and community resilience to flooding, drought, and other climate-related threats
- Expanding access to the outdoors, particularly in underserved communities



# America the Beautiful Initiative Grant Categories

**Implementation Grants**: **\$1M to \$5M** to implement projects addressing program priorities on public, Tribal, and/or private lands. Partnerships with NGOs and localities though subawards encouraged.

Planning, Collaboration and Engagement: \$200,000 to \$1M for projects that enhance local capacity to implement future on the ground actions through community-based assessments, partnership building, project design, and other technical assistance-oriented activities. Multiple partners, significant scale for the landscape/watersheds, and be completed within one year of award.



# America the Beautiful Initiative Grant Categories

**Grants to Buffer and Benefit Public Lands: \$250,000 to \$1.5M** for projects that result in direct, voluntary on-the-ground conservation actions benefiting National Forests and DoD facilities. Should be targeted toward outcomes identified in a conservation implementation plan.

Private Forests and Farmland Grants: \$200,000 to \$500,000 to support outreach and engagement with private landowners to advance voluntary conservation efforts on working lands that align with the NRCS Working Lands for Wildlife Framework (e.g. sagebrush, grasslands, bobwhite, quail, northeast turtles, golden-winged warbler).



# **Proposal Due Date**

A request for proposals is currently open, with full proposals due by July 21, 2022.

The first round of grant awards from the ATBC are expected to be announced in November 2022.
