
# Agenda Item #4 Connecting Central Florida Manufacturing and Emergency Preparedness Project Kickoff

**Background:** FloridaCommerce awarded the CFRPC a FY 2023-2024 Community Planning Technical Assistance grant to facilitate the connection of Central Florida to Manufacturing and Emergency Preparedness. The Central Florida Regional Planning Council and the East Central Florida Regional Planning Council are coordinating with FloridaMakes to provide outreach and engage the economic development and emergency preparedness community. The products from this effort will include:

- A partnership and outreach database for each county within the respective regions.
- Creation of informational materials to support the outreach and engagement activities for FloridaMakes –including a video showcasing success stories.
- Information from host informational/feedback sessions within each RPC region for the manufacturing and emergency preparedness communities (in person or virtual) as evidenced by an agenda, sign-in sheet/invite list, and an event summary.



**Background:** Staff will provide an update on the Florida Department of Environmental Protection (FDEP) Vulnerability Assessments in the region. The FDEP awarded each of the five counties and two cities (Bartow and Wauchula) in the region Resilient Florida Planning Grants to conduct a Comprehensive Vulnerability Assessment (VA) pursuant to Section 380.093, Florida Statutes.

#### The final products will include:

#### • Final Vulnerability Assessment Report will include:


- Results and conclusions, including illustrations via maps and tables, based on the statutorily required scenarios and standards in s. 380.093, F.S.;
- List of critical and regionally significant assets that are impacted by flooding. The list of critical and regionally significant assets must be prioritized by area or immediate need and must identify which flood scenario(s) impacts each asset;
- Electronic mapping data used to illustrate flooding and sea level rise impacts identified in the VA, to include the geospatial data in an electronic file format and GIS metadata; and
- A signed Vulnerability Assessment Compliance Checklist Certification.

#### Public Presentation

- Presentation of the final VA results to local governing boards, technical committees, or other appropriate officers and elected officials.
- The purpose of the presentation is to share the findings from the final VA and provide recommendations of actions for adaptation strategies and future project funding.
- The presentation will also inform the public of the results and the future risk of increased flooding and encourage community participation when identifying mitigation strategies to address the flooding vulnerabilities.

#### Local Mitigation Strategy

 The results of the VA will be used to inform the County Local Mitigation Strategy Workgroup as required by the Florida Division of Emergency Management.



#### **Grant Scope of Work**

#### PROJECT DESCRIPTION:

The Central Florida Regional Planning Council (Grantee) will conduct the Central Florida Regional Planning Council Resilience Project (Project) to include the identification of verification of regionally significant assets included in the Comprehensive Statewide Flood Vulnerability and Sea Level Rise Data Set.


#### TASKS AND DELIVERABLES:

#### Task 1: Regionally Significant Asset Identification and Verification

Description: The Grantee will review the Comprehensive Statewide Flood Vulnerability and Sea Level Rise Data Set for their region and identify any regionally significant assets, meeting the definitions in s. 380.093, that are not currently included in the Dataset. During the review, the Grantee will also verify the accuracy of the identified regionally significant assets for their region and provide updated information as needed. If any data gaps are identified, where missing or low-quality information may result in the exclusion of a or regionally significant asset, the Grantee will, in coordination with their member communities, rectify any gaps of necessary data. GIS files and associated metadata must adhere to the Resilient Florida Program's GIS Data Standards (Attachment 6), and raw data sources shall be defined within the associated metadata.

Deliverables: The Grantee will provide the following:

- 1.1: A list or spreadsheet of regionally significant assets that should be added to the Statewide Data Set, and which contains the critical assets attributes required by the Resilient Florida Program's GIS Data Standards;
- 1.2: A list or spreadsheet of regionally significant assets that are incorrectly labeled as locally significant in the Statewide Dataset and locally significant assets that are incorrectly labeled as regionally significant;
- 1.3: GIS files and associated metadata; and
- 1.4: A summary report to include recommendations to address the identified data gaps and
  actions taken to rectify them, if applicable.


**Background:** In August 2023, the Central Florida Regional Planning Council was awarded a grant from the US Department of Defense, Office of Local Defense Community Cooperation to support a Military Installation Resiliency Review (MIRR) project for the Avon Park Air Force Range in the amount of \$462,915, to be completed by January 2025.

This project integrates critical military and community resilience concerns into the strategies, plans, and investments of surrounding municipalities to foster, protect, and create a resilient future that considers the unique contributions of the Avon Park Air Force Range. This project will be led by the CFRPC, building upon our strong relationships with Range personnel, military leadership, municipal and county governments, economic development organizations, Sentinel Landscape partners, and the State of Florida.

With collaboration from key stakeholders, the Project Team will:

- Conduct a comprehensive review of present and forecasted natural and man-made threats and vulnerabilities;
- Perform table-top exercises with local military and community (public and private) leadership to review capacities of hard infrastructure such as transportation networks, electricity, communications, and water supply, and the public services necessary to respond to natural and/or man-made disruptions.
- · Develop community partnerships;
- Model impacts from potential threats and geospatial mapping; and
- Develop a Cost-benefit analysis of implementation options.

**Background:** Charles "Buck" MacLaughlin, APAFR Range Operations Officer, will provide a Mission Brief of operations at the Avon Park Air Force Range (APAFR) in preparation for the optional tour following the Council Meeting.

The APAFR occupies an area of approximately 165 square miles in central Florida. All branches of the armed forces use the APAFR for military training. The Air Force and Navy perform live bombing missions, and the Army National Guard conducts artillery exercises. The restricted airspace extends beyond the APAFR to the north and south. Low lever-training flights extend beyond restricted airspace.



The APAFR, the largest primary training range east of the Mississippi River, provides:

- World-class training for all branches of the Armed Forces;
- Approximately 106,000 acres as a daytime and nighttime training range;
- Flexible training environment and facilities; and
- Uncontrolled airfield in restricted airspace.

# Agenda Item #10 Avon Park Air Force Range (APAR) Mission Brief

The APAFR's operation impacts seven jurisdictions. Located in southeastern Polk County (1) and northeastern Highlands County (2), the APAFR is situated in Florida's heartland between two rapidly growing coastal populations to the south of the Orlando Metropolitan Area. The APAFR also borders Okeechobee County (3), and its operations impact Osceola County (4). The communities of Avon Park (5), Frostproof (6), and Sebring (7) are the closest municipalities.

The effects of encroachment created by new and proposed residential, commercial, and industrial uses threaten the future viability of the APAFR. These encroachments may hamper the APAFR's



ability to carry out crucial combat training functions and negatively impact the value of the military installation. potential Managing actual and encroachment is critical to the operations and viability of the APAFR and the quality of life for the residents of surrounding areas. Osceola County has experience the most significant growth with a 58.16% increase in population between 2010 and 2022. Polk County's population increased bν 27.89% between that same time frame.

APAFR Study Area Population Trends - 2010 to 2022


















# President's Message



# QUALITY OF Life

The RPCs assist local communities as they implement community visions and strategies. Brownfields programs across the state work to provide resources that clean up abandoned or underused commercial and industrial sites. Many RPCs also provide other services to enhance the quality of life using GIS mapping and affordable housing initiatives.



"Wills on Wheels" an AARP Community Challenge Provides legal assistance via mobile clinics throughout the Apalachee Region

Apalachee RPC, Legal Services of North Florida, and funding partner AARP

In coordination with county senior citizen agencies, this initiative, dubbed "Wills on Wheels", provided information on estate planning, end-of-life planning and assistance to help resolve heirs' property issues. At each clinic, residents were given a presentation covering The Last Will and Testament document, Healthcare Directives and Surrogate Forms, The Living Will document, The Power of Attorney Document, and Guardianship forms. Eligible attendees were provided questionnaires that will be used to draft documents prior to executing them. A total of five initial clinics were held around the region, reaching over 200 residents. Questionnaires are being received and plans are being made to coordinate meetings between the residents and volunteer attorneys for document execution.



Housing Summit Considers Potential solutions to affordable housing in Martin County, with a desire to ensure that the solutions fit local conditions

Treasure Coast RPC and Housing Solutions Council of Martin County

The Summit was well attended by the public, non-profit organizations, local elected officials, Florida Senator Gayle Harrell, and staff for other state and federal elected officials. Continuing work includes local affordable housing partners information, policy guidance, and support towards resolving this critical economic and social concern.



A Resilient Shoreline Model Ordinance template to support local governments when making updates to local plans and ordinances related to shoreline protection developed for Tampa Bay

Tampa Bay RPC and funding partner the Florida Department of Environmental Protection

The new Resilient Shoreline Model Ordinance template is one of the first of its kind in the state and defines an integrated set of policies to ensure that all types of shoreline protection strategies are designed to be resilient to changing sea levels and tidally influenced flooding through 2070. It also considers both community flood protection benefits and ecological integrity of coastal habitats and shorelines on bay waters and riverine systems. The template will help local governments streamline their review and approval processes and if adopted, will provide guidance to property owners and contractors to create shoreline projects that increase community resilience and improve local habitats and water quality. The Central Florida RPC hosted the Central Florida Economic Recovery and Resiliency Workshop | The workshop provided an opportunity for local policy makers, county administrative staff and economic development planners to discuss the framework for implementation of goals, strategies, and actions the region may pursue to achieve economic recovery and resiliency.

# EMERGENCY Preparedness

Working together, RPCs conduct cooperative statewide projects such as the award winning statewide Regional Evacuation Study, the Energy Assurance Study, and coastal resiliency planning.

A state-wide exercise of Florida's Urban Search and Rescue (USAR) teams, Mutual Aid Radio Communication teams, FSU's Florida Unmanned Aerial Search team, and the Florida Incident Support Team was hosted at Camp Blanding and the Clay County Emergency Operations Center

East Central Florida RPC, Texas A&M Engineering Extension Service (TEEX) and the Florida State Fire College

The training event simulated a realistic emergency scenario, challenging the participants to coordinate their efforts in a time-sensitive and high-pressure environment. It involved search and rescue, incident management, and austere communications missions. The exercise assessed the effectiveness of each USAR team's operational capabilities, including search and rescue techniques, medical triage, logistical support, and mobile communication. It incorporated many lessons learned from recent real-life events and offered unique technological tools that some participants may not have previously worked with. These full-scale exercises not only serve as valuable training opportunities for all involved but also highlight the importance of ongoing preparedness and continuous improvement in safeguarding communities during times of crisis.



Southeast Florida Člean Čities Coalition, the South Florida Local Emergency Planning Committee (LEPC) Region 10, Florida Transportation Systems, Inc., and the City of Hollywood Fire Rescue & Beach Safety

According to vehicle registration data, Florida is #2 in the nation for electric vehicle consumers. This trend is expected to continue along with acceleration of other alternative fuel vehicles such as propane, hydrogen, and renewable natural gas. Alternative fuel training for school buses was selected to coincide with Broward County Public School's (BCPS) contract with Blue Bird to supply 60 new electric school buses. The order replaced part of BCPS diesel fleet with zero-emission vehicles through the Florida Department of Environmental Protection's (DEP) Volkswagen Mitigation Settlement Trust Fund. This deal marks the largest electric school bus fleet purchase in Blue Bird's history. BCPS also operates the largest propane school bus fleet in the state.





#### Lessons from a mass casualty incident (MCI) in Las Vegas

Northeast Florida Regional Council's Region 3 Healthcare Coalition, the First Coast Disaster Council, and the Northeast Florida Regional Domestic Security Task Force

Deputy Chief Sasha Larkin and Lieutenant Braden Schrag of the Las Vegas Metropolitan Police Department presented to an audience of over 300 people on the Route 91 Harvest Music Festival mass casualty incident (MCI) that occurred in Las Vegas on October 1, 2017. Attendees came from various professional backgrounds, including elected officials, law enforcement, fire and rescue services, hospitals, healthcare, emergency management, and more. The presenters walked the participants through the shooting incident from start to finish while highlighting operational considerations of managing 20,000+ concertgoers and an unknown gunman. The officers also discussed recovery from an incident of this scale and magnitude. Response organizations and local hospitals endured trauma following the shooting and surge of patients. Programs and resources had to be allocated for mental health and resiliency centers to assist the community with healing from this catastrophic event.

## ECONOMIC Development

RPCs complete regional economic impact analysis using the nationally recognized REMI software, facilitate Post Disaster Redevelopment Planning, and administer revolving loan funds for small business loans and brownfields redevelopment.



The Apalachee Regional Broadband Plan and Map will ensure that the predominantly rural, nine-county Apalachee Region is in the best possible position to access state, federal, and private resources for broadband network expansion

Apalachee RPC and the Florida State University Barnebey Planning & Development Lab, with funding partner FloridaCommerce

As technology continues to advance, many rural communities are working to close the digital divide and create digital equity through widespread broadband internet access. The Study focuses on determining areas of insufficient broadband infrastructure, identifying potential service providers, and determining the needed improvements and associated costs for construction of broadband infrastructure. Community input remained a high priority throughout the project, and staff provided 25 in–person opportunities for citizens of Liberty and Wakulla counties to provide feedback on broadband internet accessibility and affordability.



### Regional Planning Councils Receive EDA Disaster Recovery Funding

Central Florida, East Central Florida, Southwest Florida and Tampa Bay Regional Planning Councils with funding partner Economic Development Administration

The impacts of Hurricanes Ian and Nicole were experienced statewide with long-term recovery efforts continuing on for the foreseeable future. With these funds each region now has a Disaster Recovery Coordinator to support long-term economic recovery and resiliency activities.



## **East Central Florida RPC Develops Economic Strategy for City** of Palm Bay

The East Central Florida RPC economic development staff researched and developed the City of Palm Bay Economic Strategic Plan. An analysis was conducted to analyze the strengths, weaknesses, opportunities, and threats related to the economic development pillars — People, Places, and Prosperity. A Strategies and Recommendations Report was completed in 2022 and included actions the city can undertake to further economic development and potential funding sources to implement those actions.

#### The Central Florida RPC and the City of Lakeland created an Award-Winning Leaner Comprehensive Plan

Central Florida RPC and City of Lakeland

Originally adopted in 1991, the City of Lakeland Comprehensive Plan contained more than 700 pages of text. To make it more user friendly, the updated Plan was reduced by more than 500 pages and reflects the citizens' vision for their community. All areas of Lakeland were engaged to determine what is important to residents of all incomes, all neighborhoods, and all ethnicities.

The Central Florida RPC drafted amendments to the Plan to unite community visioning and comprehensive planning to guide and balance the future economic, social, physical, environmental, and fiscal management of development and redevelopment of Lakeland. The Plan provides the philosophy and goals, objectives and policies that establish consistency with other City adopted regulations including the City of Lakeland Land Development Code and is consistent with Florida Statutory requirements.

#### In anticipation of a nationally branded fishing resort developing nearby, the Town of Welaka developed a vision of its downtown and plan for economic development.

Northeast Florida RC and Town of Welaka, funding partner FloridaCommerce

Through a series of six meetings, the Town of Welaka Downtown Vision was developed and included project priorities and various funding mechanisms providing a guiding document for future development.

The Northeast Florida RC designed an engagement process that was participative, appealing, and transparent. The foundation of the process was a visual preference survey that allowed town residents to vote on what architectural elements and styles they preferred using Mentimeter, a tool that allows for quantifiable feedback. Residents were presented with several architectural elements and styles such as single–story versus two–story buildings, log cabin, coastal, or board and batten designs as well as green infrastructure options and golf cart and bike paths.

## \$38 Million to Support the Shrimp Industry Recovery in Southwest Florida

Southwest Florida RPC

More than 75% of the pink shrimp harvested in the United States comes from the west coast of Florida. San Carlos Island, located in the Southwest Florida region, serves as a primary site for shrimpers to sell their catch and refuel. Hurricane Ian severely impacted not only the shrimp boat fleet in the region, but also the facilities used by shrimpers along the Gulf Coast. Prior to Hurricane Ian, more than 50 shrimp boats made up the harvesting industry fleet; today only 10 boats remain in operation. All docks on San Carlos Island were lost along with many of the support facilities including worker housing. To assist in recovery efforts, the Southwest Florida RPC wrote grants totaling over \$38 million. As they recover, the local shrimpers are considering more resilient practices for rebuilding docks, support facilities, and worker housing.





## Transportation

RPCs participate in the Transportation Disadvantaged program, as staff to local Metropolitan/ Transportation Planning Organizations, and provide planning services for Complete Streets, Safe Routes to Schools, and Greenways and Trails.



### Regional Stormwater Resilience Pilot Plan guides long range planning

Emerald Coast RC and Florida-Alabama Transportation Planning Organization (TPO)

Stormwater runoff is one of the most impactful environmental issues affecting northwest Florida. The Emerald Coast RC under the Florida-Alabama Transportation Planning Organization (TPO) is excited to be developing a Regional Stormwater Resilience Pilot Plan using Transportation Management Area (TMA) funds.

The Stormwater Resilience Pilot Plan will identify local stormwater needs and assets, focusing on impacts of projects currently included in the TPO's 20-year Long-Range Transportation Plan. The goal is to develop a process by which local governments can work with FDOT during the early planning stage to develop projects with multiple community-based benefits. This stormwater pilot project will achieve three primary goals: development of a process for identifying and aligning TPO, FDOT, and community stormwater priorities/needs; identification of up to three sites where regional stormwater parks can be designed to meet both FDOT and community stormwater needs; and the development of conceptual layout/plans for the regional stormwater parks identified, including proposed project estimates.

Gainesville Metropolitan Area Multimodal Level of Service Report identifies unmet transportation system needs and develop priority projects for the Gainesville Metropolitan Area

North Cental Florida RPC

The North Central Florida RPC provided staff support services to the Metropolitan Transportation Planning Organization (MTPO) for the Gainesville Urbanized Area—an interlocal agreement organization among the City of Gainesville, Alachua County and the Florida Department of Transportation. As part of the services provided, the North Central Florida RPC staff annually prepares the Gainesville Metropolitan Area Multimodal Level of Service Report. The Service Report provides level of service analysis for automotive/highway, bicycle, pedestrian, and transit modes of travel in the Gainesville Metropolitan Area. Council staff compiled and analyzed FDOT, City, and County traffic count data in preparing the Service Report. The bicycle, pedestrian and transit levels of service estimates of all functionally classified collector and arterial roadways within the Gainesville Metropolitan Area are provided in the report.

The Service Report enables the North Central Florida RPC, in partnership with the MTPO, to identify unmet transportation system needs and develop priority projects to enhance the operational efficiency of the transportation system for the Gainesville Metropolitan Area.

# REGIONAL CONVENING

RPCs serve as regional conveners. They lead community and regional vision efforts, engage the public in a variety of plans and programs, and maintain Strategic Regional Policy Plans.

The Central Florida RPC, in partnership with the City of Bowling Green in Hardee County, developed a downtown vision and action plan to create connections and help build Downtown Bowling Green into a thriving area Central Florida RPC and the City of Bowling Green with funding partner FloridaCommerce



The Imagine Bowling Green: Downtown Vision and Action Plan is an innovative, community-vision directed approach to the development of a Downtown Master Plan and Land Development Code amendments for implementation that promotes economic development in the community, delivers safe and convenient mobility options, provides connections within the City and beyond its borders, and works to maintain an attractive and environmentally friendly community. The planning process recognized the downtown area will not thrive without connections to other places within the city and beyond the city's limits, and identified projects and policies and the foundation for creating economic recovery and resiliency in the downtown while respecting the area's history and cultural identity.

Community leaders from public, nonprofit, and private sectors engaged in action-oriented conversations around implementing Low Impact Development (LID) in East Central Florida.

East Central Florida RPC and partners from the University of Florida Institute of Food and Agricultural Services and Volusia County

The half-day workshop identified key challenges to implementing LID and Green Stormwater Infrastructure (GSI). Break-out groups brainstormed strategies to improve water quality and reduce flooding through resilient, nature-based stormwater solutions. Additionally, mechanisms and incentives to incorporate and emphasize LID in site planning and stormwater management were discussed. The workshop was hosted at Volusia County's Lyonia Environmental Center, a hands-on educational attraction that helped highlight the need for nature-based, low-impact standards. Next, the partnership will review the workshop findings with the goal of helping local governments and entities throughout Florida implement LID and GSI principles including presentation of workshop highlights, draft LID ordinances, and companion LID Implementation Guidebook to regional stakeholders for feedback.





The South Florida and Treasure Coast RPCs held their Annual Joint Meeting at the Long Key Natural Area and Nature Center in Davie. Florida.



#### FRCA Bill Report - Updated 2/6/24

The 2024 Regular Session of the Florida Legislature opened on January 9, 2024, and is scheduled to end March 8, 2024. Below is a list of bills being actively tracked of interest to regional planning councils:

#### SB 196 – Economic Development (Simon)

Summary – Deleting the requirement that certain grants received by regional economic development organization must be matched in certain manner; removes provision requiring certain consideration; removes certain demonstration requirements of program applicants.

HB 141 – Regional Rural Development Grants (Abbott) (similar) – 2/6 8:00 a.m. on Committee Agenda Regulatory Reform & Economic Development Subcommittee

#### SB 266 – Transportation (Hooper)

Summary – Prohibiting the Department of Transportation from annually committing more than a certain percentage of revenues derived from state fuel taxes and motor vehicle license-related fees to public transit projects; authorizing the department to enter into comprehensive agreements with private entities or the consortia thereof for the building, operation, ownership, or financing of transportation facilities; requiring the department to receive three letters of interest before proceeding with requests for proposals for certain contracts; revising a presumption regarding the proximate cause of death, injury, or damage in a civil suit against the department, etc.

HB 287 Transportation (Esposito) (similar) – 2/2 In Infrastructure Strategies Committee

#### SB 298 – Saltwater Intrusion Vulnerability Assessment (Polsky)

Summary - Providing that only coastal counties and coastal municipalities that received written authorization from the Department of Environmental Protection on or before a specified date may establish construction zoning and building code exceptions to coastal construction control lines; authorizing the department to provide coastal counties, beginning on a specified date, with Resilient Florida Grant Program grants to fund saltwater intrusion vulnerability assessments, etc.

<u>HB 1079 Coastal Construction and Assessments (McFarland)</u> (similar) – 1/29 In Agriculture & Natural Resources Appropriations Subcommittee

#### **SB 328 Affordable Housing (Calatayud)**

Summary - Prohibiting counties and municipalities, respectively, from restricting the floor area ratio of certain proposed developments under certain circumstances; authorizing counties and municipalities, respectively, to restrict the height of proposed developments under certain circumstances; requiring counties and municipalities, respectively, to maintain a certain policy on their websites; revising conditions for when multifamily projects are considered property used for a charitable purpose and are eligible to receive an ad valorem property tax exemption, etc. APPROPRIATION: \$100,000,000

#### SB 438 – Term Limits (Ingoglia)

#### **SB 894 Governing Body Meetings (Bradley)**

Summary - Deleting provisions related to appointment, powers, and duties of the Florida Transportation Commission; prohibiting the designation of additional metropolitan planning organizations (M.P.O.'s) after a specified date, with an exception for certain urbanized areas; requiring each M.P.O. to report its quality performance score annually to the district secretary and to publish the score on its website, beginning on a specified date; requiring M.P.O.'s that do not achieve the minimum acceptable quality performance score within a certain timeframe to be placed under the control of the Secretary of Transportation, etc.

Summary - Deleting provisions related to appointment, powers, and duties of the Florida Transportation Commission; prohibiting the designation of additional metropolitan planning organizations (M.P.O.'s) after a specified date, with an exception for certain urbanized areas; requiring each M.P.O. to report its quality performance score annually to the district secretary and to publish the score on its website, beginning on a specified date; requiring M.P.O.'s that do not achieve the minimum acceptable quality performance score within a certain timeframe to be placed under the control of the Secretary of Transportation, etc.

#### **SB 1110 Land Development (DiCeglie)**

Summary - Revising the scope of power and responsibility of municipalities and counties under the Community Planning Act; revising exceptions from provisions governing credits against local impact fees; revising procedures regarding local government review of changes to previously approved developments of regional impact; authorizing changes to multimodal pathways, or the substitution of such pathways, in previously approved developments of regional impact if certain conditions are met, etc.

SB 1110 – 2/6, Referred to Community Affairs; Transportation; Rules

HB 1177 (Duggan) (identical) - 2/2 Bill discussed during the Office of EDR;s Revenue Estimating Impact Conference

#### SB 1184 Land Use and Development Regulations (Ingoglia)

Summary - Revising the types of data upon which comprehensive plans and plan amendments must be based; requiring that future land use plans be based on data that includes elements related to the amount of land required to accommodate anticipated growth for specified types of development and the amount of certain land located outside of urban service areas; requiring local land development regulations to establish minimum lot sizes in certain districts and infill development standards for specified housing units, etc.

SB 1184 - 1/8, Referred to Community Affairs; Judiciary; Rules HB 1221 (McClain) (similar) - 1/29 In Commerce Committee

#### SB 1386 Department of Environmental Protection (Calatayud)

Revising the aquatic preserves within which a person may not operate a vessel outside a lawfully marked channel under certain circumstances; defining the term "Florida Flood Hub"; requiring the Department of Environmental Protection to conduct enforcement activities for violations of certain onsite sewage treatment and disposal system regulations in accordance with specified provisions; requiring certain facilities and systems to include a domestic wastewater treatment plan as part of a basin management action plan for nutrient total maximum daily loads, etc. (Updates language in Chapter 380.093 Resilient Florida Program to allow for continued updates to critical asset inventories and allows funding to be used for adaptation planning based on the vulnerability assessment.)

#### SB 1420 Department of Commerce (Burgess)

Providing that amendments are deemed withdrawn if the local government fails to transmit the comprehensive plan amendments to the department, in its role as the state land planning agency, within a certain time period; revising the duties of the Florida Sports Foundation; requiring the department to establish a direct-support organization; specifying that the organization is a direct-support organization of the department and a corporation not for profit; authorizing the organization to take certain actions regarding administration of property and expenditures, etc.

Summary - Prohibiting a political subdivision from requiring employers to meet or provide heat exposure requirements beyond those required by law; prohibiting a political subdivision from giving preference to or considering or seeking information from an employer in a competitive solicitation based on or relating to an employer's heat exposure requirements, etc

#### SB 1506 Strategic Infrastructure Investment Plan (DiCeglie)

Summary - Requiring the Department of Transportation to develop a strategic infrastructure investment plan to address freight mobility infrastructure; requiring the department to coordinate with certain stakeholders to develop the plan; requiring the department to complete an assessment of certain factors and to consider the findings of the assessment in developing the plan; authorizing the department to expend moneys from the State Transportation Trust Fund to pay the cost of any projects identified in the strategic infrastructure investment plan, etc (Mentions RPCs directly as a partner in the development of the strategic infrastructure investment plan)

SB 1506 – 1/10 Referred to Transportation; Appropriations Committee on Transportation, Tourism, and Economic Development; Fiscal Policy

HB 1275 (Berfield)(similar) – 1/13 In Transportation & Modals Subcommittee

SB 452 & HB 451 Land Acquisition Trust Fund – Heartland Headwaters

Summary - Provides annual appropriation to DEP to implement Heartland Headwaters Protection & Sustainability Act; requires funds to be used & distributed for specified purposes.

#### SB 566 Land Acquisition Trust Fund – Florida Keys


Summary - Requiring an annual appropriation from the Land Acquisition Trust Fund to the Department of Environmental Protection to implement the Florida Keys Stewardship Act or to acquire land within the Florida Keys Area of Critical State Concern for specified purposes; prohibiting the department from using the appropriated funds to implement wastewater management projects or programs, etc.

#### SB 1258 & HB 1187 – Carbon Sequestration

Summary - Creating the Carbon Sequestration Task Force adjunct to the Department of Environmental Protection; providing for task force membership and duties; requiring the task force to submit specified reports to the Secretary of Environmental Protection and to the Governor and Legislature by specified dates; providing for expiration of the task force, etc. APPROPRIATION: \$350,000

#### SB 1440 – Affordable Housing Property Tax Exemptions

Summary - Affordable Housing Property Tax Exemptions for Accessory Dwelling Units; Authorizing counties and municipalities to exempt certain accessory dwelling units from ad valorem taxation, etc
