3. Old Business

a. None

4. New Business

- a. Dan welcomed the group to the University and briefed the group on the current capacity of the school and some of the architectural features on the campus.
- b. Curtis included the proposed new regions from the Florida Division of Emergency Management in the agenda packet. The FDEM moved to a 10-region which aligns with the current LEPC regions. Our new FDEM region is called "Region 7".
- c. Curtis included the Central Florida Hazardous Materials Plan draft in the meeting agenda packet. The bulk of the changes are minor edits to the region's updated census data i.e. housing, race, income, etc. The Plan includes forms for outreach (press releases, etc.) as well as local emergency response community points of contact. There were no additional changes suggested at the meeting.
- d. No regional incidents were shared among the members during the meeting. Curits shared a summary of incidents from the FDEM that occurred across the state of FL which included some incidents within our region, mainly traffic incidents within the region.

5. Subcommittee Reports

- a. James Simpson from Hardee County Fire Rescue and Tom West, Florida Department of Environmental Protection (South District Office) applications for alternate members will be received in the upcoming October SERC meeting.
- b. Recap July 2023 SERC, TTF, and LEPC Chairs and Coordinators Meetings A common discussion topic during the recent SERC meeting focused on Lithium-ion batteries and the disposal of these batteries. When these batteries are disposed of improperly or when damaged, they can catch fire. Part of the problem that has been discovered during the fire investigations is the separator fails which allows the battery to fail. Curtis shared a discussion from the SERC meeting regarding trying to discharge the batteries per USDOT specifications in plastic buckets; however, if the battery catches fire, it burns through the plastic buckets so there is some discussion regarding moving to metal buckets instead of the plastic. Curtis also noted an incident that occurred within a Lithium Batteries storage facility where a fire broke out, and was extinguished; however, other batteries at the facility continued to fail which caused problems and more fires. The responders were active for 3 months at this site, due to battery after battery catching fire.

Curtis also noted the discussion on Lithium Batteries was via an informative presentation and is hoping to encourage the presenters to attend one of our upcoming LEPC meetings to share this information. Bryan Vasser with EPA gave an excellent presentation about his response to a Lithium Battery incident.

The Florida State Fire College got \$2.5 million dollars to replace their Florida State Fire College Electronic Information Database (FCDICE). It will take 18-24 months to update the system.

An Ammonia release incident occurred at the Coca-Cola facility in Auburndale, and as a result of this incident they had to have a public meeting within 90 days of the incident to talk about the incident and explain what occurred to the surrounding community. They reached out to Curtis for assistance in organizing this public meeting. Curtis brought this to the SERC's Chairs and Coordinators meeting and got some answers that this is a standard public meeting without a required agenda and the LEPC does not need to attend the meeting. This was helpful to know to let the other LEPC coordinators across the State know how to proceed if this happens in their Regions.

The Florida Hazmat Symposium will be at the same location held in January 2023 and will be in the same time frame, around MLK Jr. weekend of 2024.

Jason Marvel with FlowMSP spoke at the SERC meetings about his free (basic version) software to all first responders across the state. Currently there are 461 fire departments across the state of Florida that use FlowMSP. They take the Tier 2 data filed in ePlan for the State of Florida and bring it into their system for response calls. The first responder will be able to conduct their pre-planning and incident response using this system. There was a question: Can the users be individuals or a group, i.e. Engine 1? It can be both; however, if it is an Engine, then it must have an email address at the County/City with that Engine 1 name in it. The City of Coco does have the full version and Curtis encouraged the group to reach out to the Chief there to discuss the software and its functionality. Some questions regarding integration of CAMEO into this system, Curtis said this is something the owners are looking into. Attendees are wondering if you can export the data and Curtis believes that data can be exported and brought into local GIS files. However, this will need to be confirmed with FlowMSP staff.

SUBJECT: <u>Hazardous Materials Incidents Report</u>

SUMMARY: The attached tables and graphs provide information on all hazardous materials incident reports received by the State Watch Office for the period of up to June 1, 2023, through August 31, 2023. Incident reports are reviewed by staff on a daily basis for compliance with Section 304 and other provisions of the Emergency Planning and Community Right-to-Know Act (EPCRA) program. They can also be used to identify facilities that may have an obligation to report under the Risk Management Planning (RMP) program.

The "Potential Section 304 Investigations" information in Table 1 is listed by Local Emergency Planning Committee (LEPC) District. These are incidents involving the release of an Extremely Hazardous Substance (EHS) or a Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) chemical at a fixed facility. In order for an incident to be covered under Section 304, the EHS or CERCLA chemical must meet or exceed its designated Reportable Quantity (RQ) and have potential for offsite exposure. Those facilities found not to be in compliance with all Section 304 reporting requirements are referred to the Division of Emergency Management's General Counsel for possible enforcement action. The incidents listed in Table 2 cover hazardous materials incidents for which evacuations, injuries and/or deaths were reported. Also note that the official cause of death is determined by the medical examiner's office. This process may take up to 90 days. The numbers for these tables were obtained from the State Watch Office incident reports, as well as other sources. This information is still being recorded and is available upon request.

The figures in Graph I show the total number of hazardous materials incidents per quarter (including Section 304) reported to the State Watch Office for the period of June 1, 2023, through August 31, 2023. The figures in Graph II compare incidents that occurred at fixed facilities to those involving transportation-related incidents during the period of January 2002 through August 2023. Note that the incidents in Graph II have been further refined to list petroleum, LNG and propane incidents.


