## 4. New Business

A. Ashley Shive with A-C-T Environmental & Infrastructure

Ashley Shive with A-C-T Environmental & Infrastructure reminded attendees that a tour of the ACT facility will be after the meeting. A-C-T is celebrating its 35th anniversary and has pledged to donate \$3,500.00 to various charities. Seven have been awarded with three left remaining. Ashley provided a quick overview of A-C-T the company. Ashly discussed and highlighted several examples of incidents.

B. Thomas Yatabe – SERC Award or Certificate of Appreciation Nomination

Included in the packets was an application for a member of the LEPC, business, individual, etc. for recognition. The state takes nominations to review then nominations attend the SERC meeting. These are for individuals who have done great work throughout

the year and are recognized on the State level. Curtis will need applications back in the next 3 weeks. Curtis suggested Domenic LetoBarone to be one of the nominations as he served on the SERC and Central Florida LEPC's training task force for several years. No additional nominations were provided.

C. Incident Report(s) Discussion for the Region

Garrett Parnell, Vice Chair, discussed an ammonia release in Lake Wales FL caused by a lightning storm. Some suction piping stopped working with ammonia still in the pipe that caused a failure in the relief valve. Approximately 100 gallons of ammonia was released, and 3 individuals were monitored by medical personnel. Pre-planning and being familiar with staff were very helpful during the incident. Discussion followed and questions were answered. Training emphasizes the importance of learning how to improve.

- B. State Emergency Response Commission (SERC) for Hazardous Materials

Curtis reported, during the SERC meetings, a long list of action items were reviewed and approved including minutes and appointments for all LEPC's across the state. The FDEM will be shifting their seven regions across the state to align with the LEPC regions in the next 3-5 years. However, Regional Domestic Security Task Force regions will not change. A grant manager is retiring at the State and that position will not be refilled. The pilot training program was completed for offshore hazmat. Several lessons were learned, and the training curriculum will be revised and relaunched. Curtis suggested being able to send the Polk County Hazmat Team to this training because of how many lakes/rivers are in the area. During the meeting it was discussed that the state would like local LEPC's to investigate various programs/manuals. Some training classes have been pre-approved. The State would like to see each LEPC create a list of what trainings they will need on a three-year rotation. Curtis discussed how we were able to hire a training consultant to work on LEPC training classes going forward. Also discussed, was the need to have a training subcommittee for our local LEPC.

#### C. Training

After the last LEPC meeting, Curtis met with Ashley Shive to go over her taking on the role of our LEPC Training Task Force Chair. Ashley agreed to be our new TTF Chair. Todd Tanner with Haz Mat Special Services volunteered to be Vice Chair and will discuss a few questions with Curtis before he can commit to this role.

## 3. Old Business

Recently received applications were not approved at the October SERC meetings, due to Hurricane Ian. Those applications will be on the next SERC agenda in January 2023.

#### 4. New Business

#### a. Cyber Florida Presentation

Emilio Salabarria with Cyber Florida presented the recently approved program to conduct Risk Assessment of the state's critical infrastructure. The first due date of the program is currently set as 1/9/2023 with the final report due on 6/30/23. This assessment will help the state determine the FY 2024 budget. Cyber Florida intends to evaluate all 16 critical infrastructure sectors, not including Ft. Meyers. The surveys will measure both public and private infrastructure knowing that they both affect each other. The goal is to establish a baseline for the critical infrastructure within the state and then create recommendations to each sector based on the responses received. Emilio further clarified the state has paid for this service and there is no cost to participate. Surveys are anonymous and will be delivered to lifeline critical infrastructure sectors. Emilio also discussed how LEPC members can help with this data collection and encouraged members to complete the survey and share with other members, vendors, contractors, etc. Questions included: Can private companies participate in the survey? YES, please spread the word as well. Curtis helped clarify if a home-based zip code is out of state, please use the in-state local office zip code. Curtis will send the presentation slides to LEPC members with the encouragement to reach out to Emilio with guestions.

b. Jason Drinkard with A-C-T Environmental & Infrastructure

Thank you again to A-C-T for hosting our LEPC meeting. A-C-T has been busy working through hurricane damage response/recovery in southwest Florida. Got contract to work with derelict vessels, will be working for approximately 1 month. Most of the A-C-T staff have temporarily relocated to Ft. Meyers for this project.
